#### Item 1:

When she reached senior four, her parents fell sick and spent their savings on medical care; and so they found difficultly paying Mary's school fees. Her uncle who is a Muslim came to her help but he is telling her to stop going to church and convert to Islam if he is to continue paying her school fees. This has left Mary confused.

### Tasks:

- (a) Explain the biblical teachings which can enable Mary to maintain her Christian faith.
- (b) How can religious approaches of our time help Mary to remain committed as a Christian?

"... It is because he knows you have broken your promise to the wife you married when you were young. She was your partner and you have broken your promise to her, although you promised before God that you would be faithful to her. Didn't God make you one body and spirit with her?
